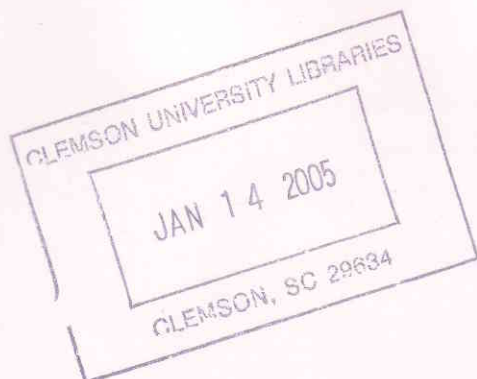

Reports of discovery of new phases, phase relationships, and microstructures apply to a broad class of materials and processes, and reports of modeling are founded on basic mechanisms. Articles on the development, fabrication, and application of advanced ceramic and composite materials are of technical importance. The Communications section contains brief reports of a scientific or technical nature about new ideas and theories relevant to ceramic science; it also contains comments regarding previously published papers.
